The UPPCC will hold the Specialty on Saturday – October 13th. There will be 18 class events in which to compete. All classes will be critiqued by a UKC judge; (Fred Lanting) quite familiar with the Presa Canario breed. Each of the class winners will receive a bronze-medallion; world-class ribbons and the top four winners will receive an engraved silver plated tray or bowl. Food and drinks will be available to all participants.

The "Old Line State United Dog Club" show organization will be conducting 4 dog shows at this same location. Two will be held on Saturday and two on Sunday. We encourage all in attendance to participate in these events and help support this fine group of dog fanciers. Exhibiting with this group could help earn your dog an International Championship.

In conjunction with the UPPCC Specialty and the Rarities dog show events, the "AMERICAN TEMPERAMENT TEST SOCIETY" has been contracted and agrees to administer their test to all dogs entered over the age of 18 months. Those dogs passing the test will be issued a "TT" number and certificate, upon which the dog will be able to carry the TT letters after their registered name; thus, proving their confidence and stability.

In 1998 I rescued what I believe to be a Lionheart Presa Canario? I live in Vermont, and our local humane society called me, and my girlfriend, to let us know; that they just received a call to pick up a dog with massive scar tissue. I rescued this dog and to my knowledge it was apparent she was used for fighting. After 5 months of getting to know each other she finally came to trust me, and my pregnant girlfriend. To make a long story short we had moved into a house a year later when my son was born, and when we brought my son home this dog never left his side; she was always with him or with anyone who was holding my son. Over the winter we had a wood stove fire and this guardian wouldn't leave my son for nothing. She died in the house and was found under the crib of my son. She was a true guardian. Hi, I was wondering if you could tell me about how many Presas are in the United States today? I ask, because 4 years ago, I rescued a pup, who; I believed to be a purebred presa. As I live in the country in Oklahoma about 30 miles south of Tulsa, I found it extremely odd that a dog this rare would turn-up on my doorstep. But then I am known to be the rescuer of large, "socalled" problem breeds and that may account for how he got here. I still have him, he had been through hell and we had over \$1,200 in vet bills the first month. By the time he got well enough to consider placing him for adoption, we had bonded so closely with him I decided he could never leave. He is now my closest companion. I am trying to understand his temperament, as he is very aggressive towards other dogs. I have worked with him a lot and he is trying hard to control his aggression, People just love him and he loves them in return. Other than the mystery of how he came to me, starving, shot twice and hit by a car, he is still a sweetheart that wins friends everywhere he goes. I no longer worry about being home at night alone, as he usually is lying beside my wheelchair, with his head resting on my foot. He is unmistakably a Presa Canario. Iris Bentley

"LAUS DEO" a little history lesson.

One detail that is not mentioned in our Capital is that there can never be a building of greater height than the Washington Monument.

On the aluminum cap, atop the Washington Monument in Washington, DC, are displayed two words: *LAUS DEO*. No one can see these words. In fact, most visitors to the monument are totally unaware they are even there and for that matter, probably couldn't care less. Once you know the *LAUS DEO* - history you will want to share this with everyone you know. These words have been there for many years, perched atop the monument, 555 feet, 5.125 inches high, facing skyward to the Father of our nation, overlooking 69 square miles which comprise the District of Columbia, capital of the United States of America.

LAUS DEO! Two seemingly insignificant, unnoticed words. Out of sight and, one might think, out of mind, but very meaningfully placed at the highest point over what is the most powerful city in the most successful nation in the world. So, what do those two words, in Latin, composed of just four syllables and only seven letters, possibly mean? Very simply, they say "PRAISE BE TO GOD!"

Though construction of this giant obelisk began in 1848, when James Polk was President of the United States, it was not until 1888 that the monument was inaugurated and opened to the public. It took twenty five years to finally cap the memorial with a tribute to the Father of our nation, "LAUS DEO"....... Praise be to God!" From atop this magnificent granite and marble structure, visitors may take in the beautiful panoramic view of the city with its division into four major segments. From that vantage point, one can easily see the original plan of the designer, Pierre Charles L'Enfant.... A perfect cross, imposed upon the landscape, with the White House to the north. The Jefferson Memorial is to the south, the Capital to the east and the Lincoln Memorial to the west

A cross you ask? Why a cross? What about separation of church and state? Yes, a cross; separation of church and state was not, is not, in the Constitution. So read on. How interesting and, no doubt, intended to carry a profound meaning for those who bother to notice. Praise be to God! Within the monument itself are 898 steps and 50 landings. As one climbs the steps and pauses at the landings the memorial stones share a message; on the 12th landing is a prayer offered by the city of Baltimore; on the 20th is a memorial presented by some Chinese Christians; on the 24th landing a presentation made by Sunday School children from New York and Philadelphia quoting Proverbs 10:7, Luke 18:16 and Proverbs 22:6. When the cornerstone of the Washington Monument was laid on July 4th, 1848 deposited within it were many items; including the Holy Bible presented by the Bible Society. "Praise be to God!" Such was the discipline, the moral direction, and the spiritual mood given by the founder and first President of our unique democracy. "ONE NATION, UNDER GOD." We are awed by; Washington's prayer for America. Have you read it? If not, this is a unique opportunity, so read on!

"Almighty God; We make our earnest prayer that Thou wilt keep the United States in Thy Holy protection; that Thou wilt incline the hearts of the citizens to cultivate a spirit of subordination and obedience to government; and entertain a brotherly affection and love for one another and for their fellow citizens of the United States at large. And finally that Thou wilt most graciously be pleased to dispose us all to do justice, to love mercy, and to demean ourselves with that charity, humility, and pacific temper of mind which were the characteristics of the Divine Author of our blessed religion, and without a humble imitation of whose example in these things we can never hope to be a happy nation. Grant our supplication, we beseech Thee, through Jesus Christ our Lord. Amen."

Hip dysplasia and diet: "The 75-Percent Rule." A 14 year study of dogs, diet and dysplasia reinforces earlier findings with younger dogs: Deliberately feeding dogs less than the recommended amount listed on the bag of food label helps reduce the severity of a painful, crippling affliction. Most breeders of large dogs have learned to curtail the amounts of protein and fat offered to large breed puppies, thereby slowing the bone growth pattern and reducing the chance of dysplasia.

A couple of years ago a study was reported by Cornell hip dysplasia experts that found the 25-percent-less diet was good for younger dog's hips. The conclusion by researchers (at the universities of Pennsylvania, California-Davis and Washington State) is this: "A lifetime maintenance of 25% less food diet restriction delayed onset and reduced severity of hip joint osteoarthritis, thus favorably affecting both duration and quality of life."

Researchers agree that almost all dogs experience some degree of degenerative changes in their joints as they age. – While they've observed that signs of canine hip dysplasia show up on x-rays "well before the geriatric period". A study showed at 5 years of age, 39 percent of the dogs who were allowed to eat freely had radiographic evidence of hip osteoarthritis, compared to 13 percent of the dogs who were fed at 75-percent rations.

New Drugs for Canine Epilepsy: Epilepsy, which occurs naturally in rodents, cats, dogs, horses, cattle, goats and non-human primates, is the most common acquired chronic neurological disorder in humans. The same goes for the dog population of which between 0.5 and 5.7 percent are affected, depending on breed and several other factors.

Up until now, the routine treatment for dogs has been the antiepileptic drugs, pheonobarbital or potassium bromide. However, there is preliminary evidence that newer human antiepileptic drugs, such as *gabapentin and levetiracetam*, *may prove useful for dogs in the near future*.

When Life is Priceless: A study of 5,200 pet owners; reported in the trade journal *Veterinary Economics*, found where the buck stops, for some of us. When asked how much they would spend to save a pet's life, 10 percent said, "up to a thousand dollars," 17 percent drew the line at \$5,000. But 70 percent of surveyed pet owners said they would pay "any amount of money."

Dogs, and the Ringworm Dermatophyte: Something to think about, the parasitic fungus *Microspotum canis* was found in the coats of 20.5 percent of the dogs living with people who had tinea corposis (ringworn) lesions. That doesn't mean that pets are the only way to get ringworm, but researchers say both cats and dogs should be considered a major source of pathogenic dermatophytes for humans even when the pets do not present clinical signs of dermatophytosis. *Dog Watch- Cornell University*

Pythiosis in Dogs: A Presa in Toronto, Ontario, Canada, died from this condition. Pythiosos is an infectious disease caused by a fungus-like organism, *Pythiumin Sidiosumthai* naturally inhabits wetlands, ponds, and swamps. In dogs, the disease usually is manifested by gastroenteritis or dermatitis. Presumably dogs become infected, by ingesting, or swimming in contaminated water and/or retrieving objects, such as sticks, from contaminated water and then chew them. Dogs with open wounds are predisposed to acquiring cutaneouspythiosis..

Gastrointestinal pythiosis is usually a fatal disease. Pathologically, the organism is highly invasive and angiotropic, so the infection can be complicated by disruption of the vascular supply. The infection typically involves the full-thickness of the stomach or intestine and sometimes extends to adjacent organs. Extensive fibrosis often results in stenosis of the affected segment of gut producing clinical signs referable to the site of infection.

Successful treatment of dogs with pythiosis is difficult. The only treatment option available for a potential cure is surgery and the goal is complete resection of the affected tissue. But the prognosis is poor. For cutaneouspythiosis involving the extremities, amputation may be required.

Sugar-Free Treats: A Danger? Xylitol, a naturally occurring sugar substitute, isn't safe for your dog. Be careful of feeding him snacks that might contain it.

We all know that chocolate is toxic to our confection-loving canines. Now sugar free treats that contain xylitol; has been shown to cause liver failure and in prove fatal in a small number of cases, according to a new report in the *Journal of the American Veterinary Medical Association* (JAVMA). Xylitol, which has been used in foods since 1960s, is a white, crystalline substance that looks and tastes like sugar and is found in many sugar free chewing gums, candies, baked goods and even some toothpastes. The powder is believed safe for human consumption – especially for diabetics.

If only it were that beneficial to dogs. Researchers at the poison control unit of the American Society for the Prevention of Cruelty to Animals, collected data on eight dogs treated after they products containing xylitol. All eight became ill and five died or had to be euthanized because of liver failure due to eating products containing the substance.

People please, be aware sugar-free gum can kill your dog. There's no doubt that xylitol can cause liver failure in dogs, the exact process by which it affects the liver is unknown, however. "Poisoning may result as a direct effect of the toxin on the liver cells themselves, which can cause changes in the **DNA** of an animal and prohibit the cells from functioning properly. It may also cause oxidative damage by free radicals. In either scenario, it is believed to cause acute cell death of liver cells.

PET DENTAL HEALTH: Periodontal disease (problems in the area around the teeth) is one of the most common health problems in dogs. It is estimated that 80% of dogs over the age of 3 suffer from some level of periodontal disease. Just as in the human mouth, the process begins with plaque, which is made up of salivary proteins and bacteria. The bacteria irritate the gum, causing an inflammatory reaction known as gingivitis. If the plaque is removed by brushing the gingivitis is resolved. If the plaque is not removed it hardens into "tartar" or "calculus." Bad breath may be noted at this point. Inflammation continues and can result in loss of bone structure around the tooth. Eventually the teeth become loose and fall out. In addition to tooth loss, periodontal disease has other, more serious, consequences. The millions of bacteria in an unhealthy mouth can spread to other parts of the body, such as the heart, lungs, kidneys, and liver, causing disease in these vital organs.

Periodontal Disease can be a painful condition and many dogs endure this pain constantly since their owners are unaware of this condition, The good news is that the disease is completely preventable! Removing the plaque reverses the inflammatory process in the gums. As we know from our own experience, plaque removal is best accomplished by brushing. In order to effective, brushing must be done every day. A soft-bristled, small headed, tooth-brush is best. Special toothpaste in such flavors as poultry or seafood helps your pet enjoy the experience. Human toothpaste should not be used as it can cause stomach upset. Letting your dog chew on special toys can also help reduce plaque.

Once calculus is present, however, a professional cleaning is required. (Calculus is the brown or opaque discoloration noted usually along the gum line on the back molars. Although the bone destruction cannot be reversed, the inflammatory can be stopped or slowed with proper treatment. Routine treatment involves ultrasonic scaling above and below the gum line. Because your veterinarian cannot simply tell your pet to "hold still" these procedures require anesthesia. Since anesthesia has inherent risks, most veterinarians use the newer and safer drugs significantly reducing the occurrence of reactions. To further minimize risks, the vet may recommend blood tests before these procedures are done. Extraction may be necessary if significant bone loss has already occurred. This can at least remove the source of the pain they may be experiencing.
